Its opening at IFEMA - Feria de Madrid last week marked the fifth city in the world, and the second European city where the exhibition was hosted. The exhibition will open in Seoul, Korea in 2019 after Madrid.

Mr. Ron Tan commented: “This award is not a demonstration of personal achievement. I am merely receiving this on behalf of all our loyal and faithful shareholders in Cityneon; and this will not be possible either without the strong support from and partnerships with all the major international studios executives - Disney, Marvel, Hasbro, Universal and Lionsgate - in US and in different parts of the world; and the staunch support of our clients, partners, suppliers and vendors worldwide.”
